LIBRARY ELECTRONIC KIOSK WITH INFORMATION IN FIVE LANGUAGES TO AVAILABLE CONSUMERS

As the next phase of the HAM–TMC Library's Jesse H. Jones Community Health Information Service's CHIA (Consumer Health Information for Asians) and CHISS (Consumer Health Information for Spanish-Speakers) projects, the Library has added an electronic touch-screen kiosk to supplement and improve our paper brochure kiosks located in the community.

With the help of a professional vendor a userfriendly touch-

screen kiosk has been designed to provide access and printing capabilities for 37 health brochures in 5 different languages: English, Spanish, Vietnamese, Chinese, and Korean. The kiosk is located at the Henington-Alief Regional Branch of the Houston Public Library at 7979 S. Kirkwood. A second kiosk will be set up at the Park Place Regional Branch of Houston Public Library, 8145 Park Place later this year. WEB WISE

MEDLINEplus, the National Library of Medicine's consumer health web site, has expanded to include an online version of Merriam-Webster's Medical Dictionary.

The Merriam-Webster Medical Dictionary contains definitions for 60,000 words and phrases used by health care professionals. Designed to be easy to read, it offers the correct spellings of medical terms, a pronunciation guide, and biographies of individuals whose names have been part of the language of medicine.

REMOTE ACCESS REGISTRATION NOW REQUIRED FOR MD CONSULT

There has been a change in the way MD Consult is made available to our patrons. Previously anyone with an MD Consult username / password could access the popular online service directly, wherever they happened to be.

As a result of the change you will be able to directly access MD Consult only from computers at the HAM-TMC Library itself, the Baylor College of Medicine, or the UT Houston Health Science Center. From any other location you will need to access MD Consult using the Library's TMC Educational Access proxy server, which is available to anyone affiliated with one of the educational institutions at the Texas Medical Center.

Friends of the Texas Medical Center Library Development Fund

The Mary & Ben Anderson Fund for Library Development has been established through the kind generosity of the Friends of the Texas Medical Center Library.

This Fund will provide money to support research and enhance the services and collections of the Houston Academy of Medicine—Texas Medical Center Library. Library staff may apply for funding to upgrade their personal skills for the benefit of the Library and its clients.

LSTA Grant Awarded

Through its Texas Treasures Grants Program, the Texas State Library and Archives Commission has awarded HAM– TMC Library's John P. McGovern Historical Collections and Research Center a one-year \$12,566 grant. Elizabeth B. White, MLS, Director of the MGgovern Center will supervise the digitization of primary historical documents from the Texas State Board of Medical Examiners' licensure files. The project will focus on files and membership records of female, non-white, and ostheopatic medical practitioners in Texas, providing an acurate demographic reference for researchers.

Digitization of approximately 8,300 such records held in the McGovern Center's biographical database, The Gazetteer of Texas Physicians, will increase its value and availability to historians, genealogical societies and libraries. The funding will be used primarily for the project's salary support.
