Budget

Center Endowment Campaign:

The next phase of the endowment campaign is to create an Advisory Committee. The goal is to raise \$8M for several programs in the McGovern Center. Rebecca Lunstroth reminded everyone to use the power point slide when lecturing to promote our Center.

MHECP and 4<sup>th</sup> Year Elective:

Dr. Boutwell said the he is getting the schedule together for the 4<sup>th</sup> year elective which starts on February 1. He and Angela Polczynski are putting together the syllabus. He reminded everyone of the March 19 symposium where the 4<sup>th</sup> year students will present their research projects. Students from UTMB and UT San Antonio are invited. He said the MHECP Banquet is scheduled for May 25.

Richard Buday – Archimage:

Dr. Cole and Dr. Spike are meeting regularly with the writers.

Randy Cohen, January 26-27:

Randy Cohen, New York Times Ethicist, will be here to give a lecture and panel discussion on January 26 and 27.

SVP United Way

An agreement with United Way has been signed to teach SVP to approximately 60 call specialists. Sylvia Villarreal will be taking on a bigger role in SVP.

Campus News:

Dr. Cole reported that Dr. Colasurdo and Kevin Dillon were lobbying in Austin for UTHealth. The budget will remain uncertain until May. The McGovern Center is active and is raising funds. The Center is of the strongest programs but does not generate income.

Sacred Vocation:

Rabbi Karff has raised \$40K to fund future residents' training. This funding should provide stability for the program for another 5 years.

MHECP:

Dr. Boutwell reported that he has collected all of the research papers and will give every student feedback. He plans to have the program sent out by Friday, 3/4.

CWEP/QEP:

Dr. Carlin reminded everyone of the June 2 one day conference focusing on Social Justice. He said he plans to present ten papers plus have a keynote speaker. The conference will be held at IMM or in the 5<sup>th</sup> Floor Gallery. Dr. Spike reported that ACT I of the story-based learning module is completed and that ACT II is very close to completion. He said they are very optimistic that it will be accepted at all six schools. A meeting in mid-March is scheduled to discuss this with the academic deans.

**Faculty Changes:**

Dr. Cole said that Dr. Erwin is on her way to Texas Tech to teach another year at the Law School. Dr. Carlin will become the Interim Director of the Medical Humanities and Ethics Certificate Program. Dr. Chaoul will transition to MDA as his main position, but will remain an Adjunct Professor in the McGovern Center, hoping to continue the meditation classes, along with other assignments. Dr. Cole has been elected next year's chair of the Interfaculty Council (IFC).

**Sacred Vocation:**

**MHECP/4<sup>th</sup> Year Elective:**

Dr. Carlin gave the following update: A couple of the MHCEP program requirements were reviewed and approved, and other issues were raised but not solved.

**Approved**

- 1) Portfolios: Change the language of the student portfolios to "strongly encouraged" rather than "required."
- 2) Final Project: Change the final project paper requirement to a minimum of 20 pages (it is currently 25 pages), and this requirement will be the same for both certificate students and non-certificate students.
- 3) Make-up: A standard make-up assignment is now to write a 2-page, single-spaced paper (1,000 words) on an assigned reading for missed events, such as grand rounds, special lectures, and so forth. Ideally, the assigned reading should have something to do with the event missed. The deadline for the make-up will be 1 month after notification of deficiency.

**Pending Issues**

- 1) How to handle faculty mentors (discussion was inconclusive)
- 2) Dinners or other spring events?
- 3) New admission process in line with scholarly concentrations

**Other Notes**

The summer reading project was deemed more or less a success. There was general agreement that there should be at least one face-to-face meeting (but not a required meeting, as some students are not here in the summer).

**CWEP:**

Dr. Spike reported that *The Brewsters* is finished but not available online because of glitches with Blackboard. Twelve hundred copies of the book have been printed and will be distributed to incoming students at each UTHealth school.

**Professionalism:**

Dr. Cole brainstormed with the faculty about professional formation and plans to write a proposal regarding this subject using the notes taken on the flip chart.
