Manuscripts should conform to APA style, with an optimal length of 18 pages, not to exceed 25 typed, double-spaced pages (excluding tables and figures), with an alphabetical list of references. Also include a diskette copy using WordPerfect v5.1 or v6.1 for PC.

Provide five copies of the manuscripts. The title page only should list the author's name, affiliation, address, and telephone number. The

abstract and first page of the text. Include an abstract of about 100 words.
